1. General Provisions

- to strengthen international sports ties.

4. Requirements for competitors and conditions for their admission

Size of the membership:

- team’s official representative;
- athletes.

Each participant admitted to the competition must have its own:

- white karate-gi approved by regulations (<http://askarate.ru/all-styles-karate.html>);
- means of protection “LC” (Meeting of the ASKFR Bureau №43 10.12.2020);
- white hand pads (LC absolute);
- white hand pads (LC weight category);
- torso vest protection (LC weight category);
- feet to protect the lower leg and foot (LC weight category);
- other means of protection, in accordance with the rules of the competition on

separate group of karate disciplines (**LC – limited contact, FC – full contact, MP – means of protection**).

ATTENTION! Each athlete has to take its own uniform equipment and personal means of protection (girls, youth, women put on white round necked T-shirt under karate-gi, hair is pulled back and fixed with a scrunchie).

November 23, 2021 – day of the team’s departure.

Competitions are held in accordance with the current rules of all style karate federation.

Judges panel has a right to make changes in competition schedule.

6. Summing up terms

Sports competitions in fights and in duels are held according to the Olympic system: the winner of the final fight takes the first place, the loser takes the second, the losers of the semi-final fight for the third place.

LC-kata-goju-ryu, LC-kata-rengokai, MP-kata-solo, LC-kata-group mixed, MP-kata-solo mixed, FC-kata-solo, FC-kata-group, FC-kata-group mixed, competitions are held by point system.

Group of disciplines with the word “kata” in age groups in individual competitions is judged: 8-9 y.o. – with flags, 10-11 y.o. – with mixed system (preliminary rounds (Olympic system) with flags, 4 athletes are in final. Final competitions are held by point system. Going from one estimation level to another athletes do different kata. In 8-9 y.o. age group kata can be repeated.

After entering the tatami athlete declares the name of the kata being performed.

Athletes acting in the disciplines of “LC-kata-rengokai” perform kata from the approved list (E-096-G-132, Meeting of the ASKFR Bureau №43 10.12.2020).

Athletes acting in the disciplines of "MP-kata-solo" perform kata from the approved list (Meeting of the ASKFR Bureau №43 10.12.2020). In the discipline "MP-kata-solo" the athlete cannot perform kata in the 2nd and 3rd round with the same difficulty coefficient.

7. Awarding ceremony

All 1st, 2nd and 3rd place winners will be given the medals and diplomas of the hosting organization.

Extra prizes for the athletes, coaches and referees could be provided by sponsors and other organizations.

8. Financing terms

Travel of athletes, coaches and judges (food, accommodation, insurance) - is provided at the expense of sending organizations.

Donation for the competition is **20 € (euros)** per participant for each discipline.

Donations are to be paid by bank transfer no later than November 10, 2021 to the bank account of the international public organization Federal All-Style Karate (Attachment 2) with the comment - "Donations for competitions (country, number disciplines)". It is also can be paid during the committee on admission on November 20, 2021. **Donations are not refundable.**

The amount of the advance payment for the appeal is 50 € (euros). In the event that the appeal is successful, money will be reimbursed.

9. Insurance

Taking part in competitions is only possible for athletes who have insurance police that is provided at the Committee on admission for each athlete.

10. Application for participants

Preliminary applications for participation in World Championship from a country or a club are submitted in Microsoft excel form at the mail address: info@iaskf.ru until 01.11.2021.

Attention! Sending organization is fully responsible for accuracy of the documents provided to the competitions. Team representative is personally responsible for the information given in the documents (noted in chapter 10) presented to the Committee of the admission.

Head judges of tatami are responsible for the harm made to participants within their competence.

If the applications are received after the expiration of the deadline or with the lack of necessary information, the athlete would be fined to 20 € (euros).

The applications for the World Championship (Attachment 1) signed by the head of the delegation and the doctor; other documents are submitted to the committee on admission on the pay of passing the admission.

List of documents for the committee on admission (for each athlete):

- passport;
- admission of a sports doctor to participate in competitions valid at the moment of competitions (originals);
- accident insurance contract valid at the time of the competition (original);
- application for admission (Attachment 4, 5);
- registration list of a competitor (Attachment 3).
