1. General Provisions

Goals and targets:

- 1. to identify the strongest athletes in the all-style karate;
- 2. to increase the sportsmanship of the athletes;
- 3. to promote and develop of the all-style karate all around the world.;
- 4. to strengthen international sports ties.

2. Place and date of the competition

4. Requirements for competitors and conditions for their admission Size of the membership:

- team's official representative;
- athletes from the country (national team) 4 people or less in each type of program and other athletes representing organizations including sports club.

Each participant admitted to the competition must have its own:

- white karate-gi approved by regulations (http://askarate.ru/all-styles-karate.html);
- means of protection "LC" (limited contact) (Meeting of the ASKFR Bureau №43 10.12.2020);
 - white hand pands (LC absolute);
 - white hand pands (LC weight category);
 - torso vest protection (LC weight category);
 - feet to protect the lower leg and foot (LC weight category);
- other means of protection, in accordance with the rules of the competition on separate group of karate disciplines (LC limited contact, FC full contact, MP means of protection).

ATTENTION! Each athlete has to take its own uniform equipment and personal means of protection (girls, youth, women put on white round necked T-shirt under karate-gi, hair is pulled back and fixed with a scrunchie).

Only athletes over 18 y.o. are allowed to participate in the IASKF World Championship, athletes over 16 y.o. are allowed to participate in kata disciplines. The age of the athlete is determined on the day of the competition.

Competitions are held in accordance with International All-Style Katare Federation' regulations.

Judges panel has a right to make changes in competition schedule.

6. Summing up terms

Sports competitions in fights and in biathlon are held according to the Olympic system: the winner of the final fight takes the first place, the loser takes the second, the losers of the semi-final fight for the third place.

Program "LC-weight category" competitions:

Time of the battle: men-3 mins, women -2 mins.

In case of draw before the first estimated technical action additional 1 min (enchesen) is announced. In case of draw in enchesen victory is awarded by judges' decision (hantei).

In LC absolute category competitions battle lasts 2 mins. In case of draw additional 2 mins battle (sai-shai) is announced. Points, warnings and punishments are not taken to additional battle. In case of draw in sai-shai victory is awarded by judges decision (hantei).

LC-kata-rengo kai, MP-kata-solo, LC-kata-goju-ryu, LC-kata group, LC-kata-bunkai, MP-kata-solo with object, MP-kata group competitions are held by point syste.

Athletes perform kata of different style in each stage and in the final. 4 people make it to the final. After entering the tatami athlete declares the name of the kata being performed.

Athletes acting in the disciplines of "Kata-Rengo kai" perform kata from the approved list (E-096-G-132, Meeting of the ASKFR Bureau №43 10.12.2020).

Athletes acting in the disciplines of "MP-kata-solo" perform kata from the approved list (Meeting of the ASKFR Bureau №43 10.12.2020). In the discipline "MP-kata-solo" the athlete cannot perform kata in the 2nd and 3rd round with the same difficulty coefficient.

A set of 3 awards is played out in all kinds of competitions: 1st place, 2nd place and 3rd place.

The national teams are ranked by the sum of points scored by the two best athletes in each discipline based on the following table:

For 17th and further places 1 point is awarded.

Disciplines where there are no competitions for the places from the 5th to the 8th each athlete gets 7 points, from 9th to 16th places each athlete gets 3 points.

Under equal points of two teams or more the advantage would be given to the team with the most 1st, 2nd etc places.

7. Awarding ceremony

All 1st, 2nd and 3rd place winners will be given the medals and diplomas of the hosting organization.

Extra prizes for the athletes, coaches and referees could be provided by sponsors and other organizations.

8. Financing terms

Travel of athletes, coaches and judges (food, accommodation, insurance) - is provided at the expense of sending organizations.

Donation for the competition is 25 € (euros) per participant for each discipline.

Donations are to be paid by bank transfer no later than November 10, 2021 to the bank account of the international public organization Federal All-Style Karate (Attachment 2) with the comment - "Donations for competitions (country, number disciplines)". It is also can be paid during the committee on admission on November 19, 2021.

Donations are not refundable.

The amount of the advance payment for the appeal is $50 \in (euros)$. In the event that the appeal is successful, money will be reimbursed.

9. Insurance

Taking part in competitions is only possible for athletes who have insurance police that is provided at the Committee on admission for each athlete.

10. Application for participants

Preliminary applications for participation in World Championship from a country or a club are submitted in Microsoft excel form at the mail address: info@iaskf.ru until 01.11.2021.

Attention! Sending organization is fully responsible for accuracy of the documents provided to the competitions. Team representative is personally responsible for the information given in the documents (noted in chapter 10) presented to the Committee of the admission.

Head judges of tatami are responsible for the harm made to participants within their competence.

If the applications are received after the expiration of the deadline or with the lack of necessary information, the athlete would be fined to $25 \in (euros)$.

The applications for the World Championship (Attachment 1) signed by the head of the delegation and the doctor; other documents are submitted to the committee on admission on the pay of passing the admission.

List of documents for the committee on admission (for each athlete):

- passport;
- admission of a sports doctor to participate in competitions valid at the moment of competitions (originals);
- accident insurance contract valid at the time of the competition (original);
- application for admission (Attachment 4, 5);
- registration list of a competitor (Attachment 3).
