1. General Provisions

Goals and targets:

- to identify the strongest athletes in the all-style karate;
- to increase the sportsmanship of the athletes;
- to promote and develop of the all-style karate all around the world;
- to strengthen international sports ties.

2. Place and date of the competition

Dates: 05-09.10.2025

Location: Russia, Chuvash Republic, Novocheboksarsk, Vinokurova Street 1A, Olympic Reserve Sports School No. 3.

4. Requirements for competitors and conditions for their admission

Size of the membership:

- team's official representative;
- athletes – from the country (national team) - 4 people or fewer in each type of program and other athletes representing organizations including sports clubs. (See Annex №6 for Russian athletes and clubs);
- judges who attended international judges' seminar.

Each participant admitted to the competition must have its own:

- white karate-gi approved by regulations (<http://askarate.ru/all-styles-karate.html>);
- 2 belts (red and white);

- means of protection, in accordance with the rules of the competition on separate group of karate disciplines (LC, FC, MP).

ATTENTION! Each athlete has to take their own uniform equipment and personal means of protection.

5. Competition program

5th October, 2025

10:00 – 17:00 – the arrival day, commission for the admission of participants to the competitions.

10:00 – 17:00 - International Judicial Seminar.

All official team representatives noted in country's applications come to the committee with documents (noted in part 11.4 of these regulations). Committee's accountant can take voluntary donation for the championship.

18.00 – Meeting with representatives of teams.

14.00 - 18.00 – weighing (registration) of the athletes taking part in competitions

6th October, 2025 (athletes should be accompanied by their representatives): LC-weight category.

Weighting allowance – 200 gr.

Only athletes over 18 y.o. are allowed to participate in the World Championship, athletes over 16 y.o. years are allowed to participate in kata disciplines.

The age of the athlete is determined on the day of the competition.

Competitions are held in accordance with International All-Style Karate Federation's regulations.

6. Summing up terms

6.1 Sports competitions in fights and in biathlon are held according to the Olympic system: the winner of the final fight takes the first place, the loser takes the second, the losers of the semi-final fight for the third place.

6.2 Program "LC-weight category" competitions:

Time of the battle: men– 3 min, women – 2 min.

In case of draw before the first estimated technical action additional 1 min (enche-sen) is announced. In case of draw in enche-sen victory is awarded by judges' decision (hantei).

6.3 In «LC-absolute category» competitions battles last 2 min. In case of draw, an additional 2 min battle (sai-shiai) is announced. Points, warnings and punishments are not taken to additional battles. In case of draw in sai-shai victory is awarded by judges' decision (hantei).

6.4 Competitions in the "LC-weight category" program (Jiu-Kumite):

The time of the match (net time): for men – 3 min., for women – 2 min.

The awarding and assigning of points for technical actions by the referee team takes place without stopping the match. In case of violation of the rules of the competition, the match is stopped, the violation is announced and recorded in the protocol of the course of the match. At the end of the match, in case of equal number of points, the victory is awarded by the decision of the judges (hantei). Protective equipment: torso protection vest, shin protection, optional instep pad, and other equipment according to the rules of the All-Style Karate discipline (LC).

6.5 The number of participants in the categories "LC-weight category", "FC-weight category", "MP-weight category" is 3 athletes, the category is held according to the round robin system. The winner is determined by the number of victories. If the number of wins is equal, the winner (loser) is determined by the number of points. In case of equal sum of points, the number of scored ippons (LC) and the number of knockdowns (FC, MP) are counted. If the equality is maintained in terms of ippons and knockdowns, then the winner (loser) is determined by the lowest (highest) number of penalties (chui). Athletes ranked second, third place, or first, second are determined by the results of a personal meeting. In case of equality of all indicators to determine the winner, the category is held again.

6.6 In the sport discipline "LC-biathlon", a duel is a match in which each pair of athletes competes sequentially in sets of technical techniques ("kata") and in duels ("kumite"):

6.6.1. The two-event always begins with sets of technical techniques "kata".

6.6.2. In the judging of the two-day competition, the judges are guided by the Rules for Judging the Kata Competition by the method of comparison (by flags), and in the judging of the matches, by the Rules for Judging the Matches in the LC-absolute category (Ippon).

6.6.3. In the Kata competition, athletes perform Kata of their choice from the list of Kata allowed by the rules of all-style karate, and the Kata cannot be repeated.

6.6.4. Starting from the semi-final and the final of the two-event competition, each pair of athletes competes sequentially first in "kata" and then in "match." The winner is determined by the sum of victories in kata and match.

6.6.5. There can be no draw in "kata."

6.6.6. In the event of a draw in the main time, "saishai" is not declared.

6.6.7. In the event that the number of victories in the "LC-biathlon" is equal:

6.6.8. In the semi-final, an additional "kata" match is assigned.

6.6.9. In the final and the match for third place, an additional "kumite" - "saishai" match is assigned. In the event of a draw in the additional match, the victory is awarded by the judges' decision ("hantei").

6.7. In competitions in the program "LC-team competitions" the composition of the team is 3+1 (reserve).

Before each team meeting the representative of the team must submit the order of performance of the team to the secretariat table.

The winner is determined by the number of victories.

In the case of a draw, the winner is determined by the number of points scored.

In case of a tied result by the number of ippons. If the draw result is maintained, an additional duel is appointed, which is held according to the rules "LC-weight categories".

6.8 LC-kata-rengokai, LC-kata-vado-ryu, MP-kata-solo, LC-kata-goju-ryu, LC-kata-group, LC-kata-bunkai, MP-kata-solo with object, MP-kata-group competitions are held by point system.

Athletes perform kata with different style in each stage and in the final. There are 4 people going to the final. After going out on tatami, the athlete declares the name of the kata which he is going to perform.

In age groups: men, women LC-kata competition (LC-kata-rengokai, LC-kata-goju-ryu, LC-kata-vado-ryu, LC-kata-groups) are held in 3 rounds according to the points method.

In each round and final, the athletes perform a different kata from the previous ones with different coefficients

1) The first round (points from 5.0 to 7.0). In the second round, no more than 12* people who have scored the highest points pass. If there are less than 8 participants in the first round, they can be eliminated. Therefore, the competition will be held in two rounds.

2) Second round (points: 6.0 - 8.0): The four participants with the highest scores will advance to the finals.

3) The order of the participants in the second round will be the same as in the first round.

4) Third round (Finals) (points: 7.0 - 9.0): The kata in the final must be different from the kata in the first and second rounds.

5) A draw is held to determine the order of the finalists' performances.

6) If there is a tie, the coefficient is not taken into account.

The winner is determined based on the scores of the final round.

*Recommended:

If there are fewer than 20 participants in the category, 8 participants advance to the second round.

If there are more than 20 participants in the category, 12 participants advance to the second round.

6.8.1. Athletes acting in the disciplines of "LC-kata" and "LC-kata solo" perform kata from the approved list, application №5:

LC-kata-rengokai - E-096-G-132;

LC-kata-goju-ryu – G049LC -G077 LC;

LC-kata-vado-ryu - B-019LC-B-032LC, V-033LC-V-048LC, S133LC-S164LC;

MP-kata-solo – A001MP-A018MP; D078MP-D095MP.

LC-kata winners are determined in 3rd round.

6.8.2. In the discipline "MP-kata-solo" the athlete cannot perform kata with the same difficulty coefficient. Difficulty coefficient of the 1st round is not counted in score of the 1st round.

In the case of equality of points among athletes in the first or second round, the winner is determined by the performance of athletes with the same points, an additional kata. Additional kata must have the same difficulty coefficient as the kata performed by athletes in the round with the same points, but must not be repeated.

In the second round of the competition athletes 8 (eight) who scored the highest number of points in the first round go to the second round. In the third round of the competition (final) 4 (four) athletes who scored the highest number of points go into the second round.

6.8.3. In MP-kata-solo with object program:

in 1st round athletes perform long types of weapons (BO, EKU, DZE),

in the 2nd round – twin or flexible weapon (twin – KAMA, TONFA, SAI, flexible – nunchaku),

in 3 round - twin or flexible weapon (it is forbidden to use the same weapon).

8 athletes go to the 2nd round, 4 athletes go to final.

In MP-kata-solo with object winners are determined by points in all 3 rounds.

In case of outage athlete perform kata with long weapon.

6.9 In the competitions in all types of the program is played out a set of 3 awards: 1, 2 and 3 places.

7. Awarding ceremony

7.1 All 1st, 2nd and 3rd place winners will be given the medals and diplomas of the hosting organization.

7.2 Extra prizes for the athletes, coaches and referees could be provided by sponsors and other organizations.

8. Financing terms

8.1 Travel of athletes, coaches and judges (food, accommodation, insurance) - is provided at the expense of sending organizations.

8.2 Donation for the competition is **2.500 rubles** per participant for each discipline (personal participation).

For participation in kata-group and group competition the donation is 1.500 rubles in each type of program (personal participation in the team).

8.3 Payment of the voluntary donation is made by no later than **1th October, 2025** to the bank account of the international public organization "All-Style Karate Federation" (Attachment 2) with the comment - "Voluntary donations for competitions (country, number disciplines)". It is also can be paid during the committee on admission on **5th October, 2025**.

Donations are not refundable in case an athlete cannot take part in the competitions.

8.4 The amount of the advance payment for the appeal is 5000 rubles. In case the appeal is successful, money will be reimbursed.

9. Security

9.1 Participants and spectators' security are made in accordance with the requirements of the Rules of Security in the Conduct of Official Sports Competitions, approved by the Decree of the Government of the Russian Federation of 18th April 2014. №353 and in accordance with the Regulations of official sport competitions holding and all-style karate competition's holding.

9.2 Competitions are held at the sport venue, included in the All-Russian Register of Sports Venues in accordance with the Federal Law of 4th December, 2007, 329-FZ «On Physical Culture and Sports in the Russian Federation».

9.3 Provision of medical care is carried out in accordance with the order of the Ministry of Health of the Russian Federation from 23.10.2020 1144n. " On the approval of the procedure for the organization of medical assistance to persons engaged in physical culture and sports (including in the preparation and conduct of physical activities and sports events), including the procedure for medical examination of persons, wishing to undergo sports training, to engage in physical training and sports in organizations and (or) to fulfill the standards of tests (tests) of the All-Russian Physical Culture and Sports Complex "Ready for work and defense" (GTO)" and forms of medical certificates of admission to physical education and sports.

10. Insurance

10.1 Participation in sports competitions is carried out only if there is a life and health insurance policy during the competitions (sports insurance with the indication of the sport «all-style karate»).

11. Application for participants

11.1 Preliminary applications for participation in World Championships from the country or club are submitted in Microsoft excel form at the mail address: vsekarate@rsbi.ru until **28.09.2025**.

11.2 **Attention!** The commanding organization is fully responsible for the correctness of documents accompanying athletes to competitions. The representative of the team is personally responsible for the accuracy of the information provided in the documents listed in paragraph 11.4 before the approval commissions.

11.3 In case of submission of an application with delay, as well as lack of necessary information in it to the team leader will be penalized - for each participant 2.500 rubles.

11.4 At the Commission for the admission of participants of competitions, the **TEAM REPRESENTATIVE** together with the official application should present (declare) the presence of the following documents for each athlete, which are marked on the registration list:

- an identity document with a photo (passport)
(the original of the document is presented at the check-in or registration);
- admission of a sports doctor to participate in competitions valid at the moment of competitions (originals) for Russian athletes;
- application for admission to participate ((annex 3.4) (original is available on request, available));
- accident insurance contract valid at the time of the competition (original);
- copy of the document (possibly in electronic form) about the payment of the starting fee.
