1. General Provisions

Goals and targets:

- to identify the strongest athletes in the all-style karate;
- to increase the sportsmanship of the athletes;
- to promote and develop of the all-style karate all around the world;
- to strengthen international sports ties.

2. Place and date of the competition

Dates: 13.11.2025-17.11.2025

Location: Republic of Bashkortostan, Salavat city, Kluchevaya street 1/1, Sports complex «Palace of Sport Neftechimik».

Referees Corps of international competitions will be formed as a result of the work of the judicial seminar.

4. Requirements for competitors and conditions for their admission

Size of the membership:

- team's official representative;
- athletes;
- judges.

Each participant admitted to the competition must have its own:

- white karate-gi approved by regulations (<http://askarate.ru/all-styles-karate.html>);
- 2 belts (red and white);
- means of protection, in accordance with the rules of the competition on separate group of karate disciplines (LC, FC, MP).

ATTENTION! Each athlete has to take their own uniform equipment and personal means of protection.

5. Competition program

November 13, 2025 /thursday/ - the arrival day

15:00 – 20:00 – commission for the admission of participants to the competitions.

All official representatives of the teams specified in the applications shall arrive at the commission with the documents specified in annex. 11 of this regulation.

Only athletes over 18 y.o. are allowed to participate in the competitions, athletes over 16 y.o. years are allowed to participate in kata disciplines.

The age of the athlete is determined on the day of the competition.

In case of emergency, the Chief Judge has the right to adjust the schedule.

6. Summing up terms

6.1 Sports competitions in the groups of sports disciplines LC, FC, MP are held according to the Olympic system: the winner of the final fight takes the first place, the loser takes the second, the losers of the semi-final fight for the third place.

6.2. Competitions in the "LC-weight category" program (Jiu-Kumite):

The time of the match (net time): for men – 3 min., for women – 2 min.

The awarding and assigning of points for technical actions by the referee team takes place without stopping the match. In case of violation of the rules of the competition, the match is stopped, the violation is announced and recorded in the protocol of the course of the match.

At the end of the match, in case of equal number of points, the victory is awarded by the decision of the judges (hantei) according to the rules (para. 6.5. of this regulation).

6.3. Program "LC-weight category" competitions:

Time of the battle: men– 3 min, women – 2 min.

In case of draw before the first estimated technical action additional 1 min (enche-sen) is announced. Points, warnings and punishments in the battle are carried over into additional time. In case of draw in enche-sen victory is awarded by judges' decision (hantei).

6.4. In «LC-absolute category» competitions battle last 2 min.

In case of draw, an additional 2 min battle (sai-shiai) is announced. Points, warnings and punishments are not taken to additional battles. In case of draw in sai-shai victory is awarded by judges' decision (hantei).

6.5. The number of participants in the categories "LC-weight category", " FC-weight category ", "MP-weight category " is 3 athletes, the category is held according to the round robin system. The winner is determined by the number of victories. If the number of wins is equal, the winner (loser) is determined by the number of points. In case of equal sum of points, the number of scored ippons (LC) and the number of knockdowns

(FC, MP) are counted. If the equality is maintained in terms of ippons and knockdowns, then the winner (loser) is determined by the lowest (highest) number of penalties (chui). Athletes ranked second, third place, or first, second are determined by the results of a personal meeting. In case of equality of all indicators to determine the winner, the category is held again.

6.6. In the sport discipline "LC-biathlon", a duel is a match in which each pair of athletes competes sequentially in sets of technical techniques ("kata") and in duels ("kumite"):

1. Discipline "LC-biathlon" always begins with sets of technical techniques "kata". The winners in «kata» go to the next round of competitions - «fights».

2. In the judging of the "LC-biathlon", the judges are guided by the Rules for Judging the Kata Competition by the method of comparison (by flags), and in the judging of the matches, by the Rules for Judging the Matches in the LC-absolute category (Ippon).

3. In the Kata competition, athletes perform Kata of their choice from the list of Kata allowed by the rules of all-style karate, and the **Kata cannot be repeated**.

4. Starting from the semi-final and the final of the two-event competition, each pair of athletes competes sequentially first in "kata" and then in "match." The winner is determined by the sum of victories in kata and match.

4.1. There can be no draw in "kata."

4.2. In the event of a draw in the main time, "saishai" is not declared.

4.3. In the event that the number of victories in the "LC-biathlon" is equal:

In the semi-final, an additional "kata" match is assigned.

4.4. In the final and the match for third place, an additional "kumite" - "saishai" match is assigned. In the event of a draw in the additional match, the victory is awarded by the judges' decision ("hantei").

6.7. LC-kata-rengokai, LC-kata-vado-ryu, MP-kata-solo, LC-kata-goju-ryu, MP-kata-solo with object competitions are held by point system in 3 rounds. In each round and final, the athletes perform a different kata from the previous ones with different coefficients:

1) The first round (points from 5.0 to 7.0). In the second round, no more than 12* people who have scored the highest points pass. If there are less than 8 participants in the first round, they can be eliminated. Therefore, the competition will be held in two rounds.

2) Second round (points: 6.0 - 8.0): The four participants with the highest scores will advance to the finals. The order of the participants in the second round will be the same as in the first round.

3) Third round (Finals) (points: 7.0 - 9.0) to determine the order of performance of the participants in the final, a draw is made.

4) If there is a tie, the coefficient is not taken into account.

The winner is determined based on the scores of the final round.

*Recommended:

If there are fewer than 20 participants in the category, 8 participants advance to the second round.

If there are more than 20 participants in the category, 12 participants advance to the second round.

6.7.1. Athletes acting in the disciplines of the next disciplines do kata from the List:

LC-kata-rengokai - E-096-G-132;

LC-kata-goju-ryu – G049LC -G077 LC;

LC-kata-vado-ryu - B-019LC-B-032LC, V-033LC-V-048LC, S133LC-S164LC.
6.7.2. MP-kata-solo – A001MP-A018MP; D078MP-D095MP.

In the discipline "MP-kata-solo" the athlete cannot perform kata with the same difficulty coefficient. Difficulty coefficient of the 1st round is not counted in score of the 1st round.

In the case of equality of points among athletes in the first or second round, the winner is determined by the performance of athletes with the same points, an additional kata. Additional kata must have the same difficulty coefficient as the kata performed by athletes in the round with the same points, but must not be repeated.

The athletes 8 (eight) who scored the highest number of points in the first round go to the second round of the competition. In the third round of the competition (final) 4 (four) athletes who scored the highest number of points go into the second round.

In MP-kata-solo winners are determined by points in all 3 rounds.

6.7.3. In MP-kata-solo with object program:

Athletes 14-15 y.o. in 1st round perform long types of weapons (BO, EKU, DZE), in the 2nd round – twin or flexible weapon (twin – KAMA, TONFA, SAI, flexible – nunchaku), in 3 round - twin or flexible weapon (it is forbidden to use the same weapon).

Athletes 16-17, 18-20 y.o. in 1st round perform long types of weapons (BO, EKU, DZE), in the 2nd round – twin or flexible weapon (twin – KAMA, TONFA, SAI, flexible – nunchaku), in 3 round - twin or flexible weapon (it is forbidden to use the same weapon).

In MP-kata-solo with object winners are determined by points in all 3 rounds.

6.8. Final results (protocols) and reports on paper and electronic media are presented in the Ministry of Sport of Russia.

6.9. In the competitions in all types of the program is played out a set of 3 awards: 1, 2 and 3 places.

7. Awarding ceremony

7.1 All 1st, 2nd and 3rd place winners will be given the medals and diplomas of the hosting organization.

7.2 Extra prizes for the athletes, coaches and referees could be provided by style federations, sponsors and other organizations.

8. Financing terms

Travel of athletes, coaches and judges (food, accommodation, insurance) - is provided at the expense of sending organizations.

Donation for the competition is **2.500 rubles** per participant for each discipline.

Cash payment is possible on the day of the admission commission. Non-cash payment deadline 10 November 2025.

Donations are not refundable in case an athlete cannot take part in the competitions.

The financing of expenses for the preparation and holding of competitions is provided at the expense of ROO «Federation of sports and adaptive karate RB».

9. Security

9.1 Participants and spectators' security are made in accordance with the requirements of the Rules of Security in the Conduct of Official Sports Competitions, approved by the Decree of the Government of the Russian Federation of 18th April 2014. №353 and in accordance with the Regulations of official sport competitions holding and all-style karate competition's holding.

9.2 Competitions are held at the sport venue, included in the All-Russian Register of Sports Venues in accordance with the Federal Law of 4th December, 2007, 329-FZ «On Physical Culture and Sports in the Russian Federation».

9.3 Provision of medical care is carried out in accordance with the order of the Ministry of Health of the Russian Federation from 23.10.2020 1144n. " On the approval of the procedure for the organization of medical assistance to persons engaged in physical culture and sports (including in the preparation and conduct of physical activities and sports events), including the procedure for medical examination of persons, wishing to undergo sports training, to engage in physical training and sports in organizations and (or) to fulfill the standards of tests (tests) of the All-Russian Physical Culture and Sports Complex "Ready for work and defense" (GTO)" and forms of medical certificates of admission to physical education and sports.

10. Insurance

Participation in sports competitions is carried out only if there is a life and health insurance policy during the competitions (sports insurance with the indication of the sport «all-style karate») which is submitted to the admission commission for each participant of sports competitions. The insurance of participants in sports competitions is carried out at the expense of extrabudgetary funds in accordance with the legislation of the Russian Federation.

Attention! The commanding organization is fully responsible for the correctness of documents accompanying athletes to competitions. The representative of the team is personally responsible for submitting the documents listed in para. 11 to the approval committees.
